Details:

Marketing Executives will be eligible to earn the trip to Convention or a portion of their trip to convention based upon the number of 2012 Convention Dollars earned during the contest period from September 2011 – March 2012.

Qualifications:

During the contest period, Marketing Executive must enroll and develop a minimum of two (2) or above new first time Personally Enrolled Directors to earn the Convention Dollars.

Rules:

- All Participants are required to pay an initial deposit of RM300 to reserve their spot on the trip. Convention Dollars calculation will begin upon the month of the initial deposit has been made. Deposit is non-refundable.
- If a Marketing Executive advance in status but does not have the required minimum 25 Preferred Customer Growth per advancement (Activities No.5-7), the lesser of the number of advancements or Net Preferred Customer Growth divided by 25 will determine the number of qualifying status advancements for the purpose of awarding Convention Dollars. Net Organizational Preferred Customers must maintain Preferred Status until 31st March 2012.
- Estimated Convention trip expenses is RM11,000. The actual amount will be announced in February 2012. Participants are required to make payment of all outstanding trip expenses after subtracting the current convention dollar earned; payment has to be made before 29th February 2012. Final Convention Dollars earned will be announced on 15th April 2012. Reimbursements will be made on 30th April 2012 to qualified participants for any excess amount paid above and beyond the total Convention Dollars earned.
- Convention Dollars can only be used toward attending the US Convention. Any Convention Dollars earned in excess of the cost of the trip are non-refundable with the exception of the initial deposit.
- 2012 International President Club Qualifier is not entitled to participate in the 2012 US Convention Fast Track.
- Marketing Executives are responsible for obtaining the proper US Visa. Convention Dollar is non-refundable for any Marketing Executives who fail to participate in the trip due to personal reasons.
- Only business account's holder and legitimate spouse are eligible to participate and attend the 2012 US Convention.
- All initial deposits, Convention Dollars and Convention trip expenses are non-transferable and non-redeemable for cash or prizes.
- Melaleuca Southeast Asia reserves the right to determine the qualifying final attendees of 2012 US Convention.

活动规则:

- 所有参赛者需缴付RM300报名费以预先保留其年会行程名额。年会基金将于其缴付报名费的当个月份开始计算。此报名费恕不退还。
- 如事业代表晋阶数阶衔时未达所需条件(活动项目5-7), 计算公式将是以前组织组织优惠顾客净增长人数除以25位组织组织优惠顾客净增长人数之指数做为计算。所有组织组织优惠顾客净增长人数需保持优惠资格至2012年3月31日方可计算为年会基金。
- 年会旅费金额预计约RM11,000, 实际金额将于2012年2月公布。参赛者须于2012年2月29日前先缴交差额。年会基金将于2012年4月15日结算, 并于4月30日将以旅费最后的差额金额做收取或退还。
- 年会基金只限于此美国年会行程。如赚取之年会基金超越此年会旅费将不做退还, 报名费除外。
- 符合2012年总裁俱乐部之事业代表将不可同时享有年会基金, 此年会基金恕不退还。
