**Terms and Conditions** (Please read carefully)

The applicant, in consideration of the mutual promises, covenants, and conditions set forth in this International Independent Marketing Executive Application and Agreement, hereby acknowledges, warrants, covenants, and agrees:

1. I will be and will remain at all times while this agreement is in force, an active Marketing Executive with the Melaleuca entity in the country of my residence ("Melaleuca") and I agree at all times to abide by the terms of my Independent Marketing Executive Agreement and Melaleuca's Statement of Policies, as such policies may be amended from time to time.
2. I understand that this agreement is directly with Melaleuca and is separate and distinct from any agreement I have previously entered into with Melaleuca. I understand that this agreement, if approved, will authorize me to act as an International Marketing Executive in the international markets indicated above.
3. I understand that in order to qualify for and receive commissions from my international organization in each country, I must meet the conditions for earning commissions in that country.
4. I will not directly or indirectly import any unapproved Melaleuca products or literature into any country. I acknowledge that to do so would cause irreparable damage to Melaleuca and Melaleuca's affiliates.
5. I will comply at all times with all applicable laws, rules and regulations and other legal requirements of each country in which I function as an International Marketing Executive, and with the Statement of Policies of the Melaleuca affiliate operating in each country.
6. I hereby release Melaleuca and Melaleuca's affiliates and their employees from all liability for any of my acts and omissions. I agree to waive any claims or causes of action which I may have occasion to assert respecting my status or conduct as an International Marketing Executive arising out of any of my acts or omissions. I hereby agree to indemnify and hold harmless Melaleuca and Melaleuca's affiliates and their employees for any and all claims, actions or liabilities arising out of any of my acts, omissions or representations related in any way to my enrolling or other activities.
7. I understand that I will not be entitled to receive any commissions with respect to my international organization until Melaleuca received the signed original of this agreement and the signed original Customer Membership Agreement or Independent Marketing Executive Agreement of at least one customer or Marketing Executive that I enroll in one of the international markets covered by this agreement. I understand that my application to be an International Marketing Executive will not be deemed accepted by Melaleuca until I have received and cashed my first commission check for products purchased by the Customer or Marketing Executive I enrolled.
8. I understand and agree that upon notification to its Marketing Executive in an official publication of Melaleuca or in a written document sent to me in my product order or by some other means authorized by Melaleuca, Melaleuca may at its sole discretion amend the International Marketing Executive Program, and/or the terms of this International Marketing Executive Application and Agreement and each foreign affiliate may, at its discretion amend its Policies, Independent Marketing Executive Agreement, Customer Membership Agreement and Compensation Plan. I agree to abide by any and all such amendments. The continuation of my International Marketing Executive Agreement and of my Melaleuca business or my acceptance of commissions from Melaleuca constitutes my acceptance of and sufficient consideration for any and all amendments.
9. My right to act as an International Marketing Executive or receive commissions from Melaleuca may be revoked at any time that Melaleuca has evidence that I have not conducted myself in accordance with the terms and conditions of this agreement, or the Melaleuca Statement of Policies, or the Policies of a Melaleuca affiliate.
10. My violation of any of the terms of this agreement, Melaleuca's Statement of Policies, or the Statement of Policies of a Melaleuca affiliate in any country in which I am acting as an International Marketing Executive may result, at Melaleuca's discretion, in forfeiture of commission checks from Melaleuca and/or Melaleuca's affiliates, loss of all or part of my Melaleuca marketing organization, cancellation of this agreement, or my Independent Marketing Executive Agreement, or other disciplinary action deemed appropriate by Melaleuca.
11. If any provision herein is held to be invalid, all other provisions will remain valid and enforceable.
12. The term of this agreement is one year. This agreement will be automatically renewed on each anniversary of the date hereof, unless previously canceled. I authorize Melaleuca to charge my account on file the applicable renewal fee set forth on the front of this agreement on an annual basis for the purpose of automatically renewing my International Marketing Executive Agreement.
13. This agreement constitutes the entire agreement between Melaleuca and me and supersedes all other agreements or understandings, whether written or oral, with respect to my International Marketing Executive Agreement with Melaleuca.
14. The terms of this agreement shall be governed by the laws of the country in which I am enrolled as an Independent Marketing Executive. If that country is the United States, the terms of this agreement shall be governed by the laws of the State of Idaho.
